### General Information

We begin by undertaking a review of the property and assessing how many signs are required and where to place them. Usually, a minimum of two signs are needed before removal of vehicles can take place.

A variety of signs are available for different restrictions. Sign installation can be arranged by us or by your own resources. Please contact us for the current cost of signs and installation services.

After installation, an account is established in our system that records the details about your property and tailors the service we provide to your needs. You can, for instance, request restrictions on parking times, authorized vehicles, handicap space/fire lane violations and more. Removal of vehicles is done as per your specification.

Enforcement of restrictions can be done on a case by case basis by call-ins from you or your designates, or by regular or enhanced patrols by us. For call-ins, a code is provided to place removal requests. A list of authorized contacts can be provided by you for vehicle removal privileges. This list can be updated at anytime. All callers will be asked to provide some particulars about the vehicle to be towed (manufacturer, colour, and license plate number) as well as its location and the violation. Calls made by your designates are kept confidential.

**The cost of having a vehicle towed under this program is borne by the registered owner of the vehicle, not by you. Aside from signage and associated installation costs, the basic management program is free.**

*This program does not include the removal of unlicensed, uninsured or derelict vehicles. We can, however, assist in solving these problems.*
